Jürgen Grützner: Prior to his position as Managing Director of the VATM (Association of the Providers of Telecommunications and Value-Added Services) since 1998, Jürgen Grützner led the target group Post and Telecommunications of the CDU/CSU-Bundestagsfraktion (parliamentary party of the Christ Democrats). In this duty and as speaker to the post-political responsible, he was in charge of the negotiations of the Acts leading to the market liberalization, starting with the Postreform II through the Act of telecommunication. From 1990 - 1993 Mr. Grützner was head of the press and communication department of the Deutsche Post AG in Cologne. Mr. Grützner started his professional career in a lawyer office. The studied attorney is married and has two children.
